We are Solicitors to Jude Ezeobi, ESQ. (hereinafter referred to as "our client") and on whose instructions we hereby write to you.

It is our client's brief that today, 21st August, 2024 Felix Ashimole, Esq. a lawyer who is the publisher of an online publication known as Kubwa Express .com, made false and malicious statements about him in an online publication i.e. Kubwaexpress.com (<https://kubwaexpress.com/2024/08/21/family-of-late-wigwe-university-registrar-warns-against-dealing-with-jude-obiora-ezeobi-her-purported-husband/>). A copy of the publication and the link to the website where the false statement was originally published are hereto attached as **Annexure KE1**.

After making the online publication, by 1:16pm today, the said Felix Ashimole, Esq. shared the publication with our client via direct messaging on WhatsApp. Our client placed a telephone call to him, informing him that the publication as it relates to his person (i.e. our client) were false and as a journalist and professional colleague, he (Felix Ashimole, Esq. and Kubwa Express.com) should have verified the contents of the publication from him and given him a right of response before making the publication. Our client further requested him to delete the publication. However, Felix Ashimole, Esq. failed and refused to delete it but proceeded to further share the publication on the WhatsApp platform of the Law Centre which has over 540 lawyers, professors and Senior Advocates of Nigeria as members. Kindly see Whatsapp screenshots as attached and marked **Annexure KE2**.

Felix Ashimole, Esq. of Kubwa Express.com and his conspirators, in the bid to calumnise, defame and assassinate the character of our client and deceive the unsuspecting public to gain online followership, mischievously screenshot a post made by a former neighbor Prince "Christopher Odianarewo (08102743956)" on the whatsapp platform of the Hillside Neighborhood Association where our client and his ex-wife (now deceased) were founding members and maliciously / criminally altered it to suit their calumny against our client by claiming that our client set up a whatsapp group / committee of friends to solicit support.

To wit:

"The family is shocked and scandalised that Mr. Ezeobi and his "Committee of Friends" has formed a condolence WhatsApp Group aimed at soliciting support from unsuspecting sympathisers towards Ulonna's burial". Kindly see page 4 of Annexure KE1 and Annexures KE3 and KE4 respectfully. As seen in Annexure 4, the Hillside Neighborhood Association whatsapp group was created on 4/11/17, ie 4 November 2017. As opposed to the malicious falsehood by Felix Ashimole, Esq. of Kubwa Express.com

Our client released a statement on the WhatsApp platform of the Law Centre demanding Felix Ashimole, Esq. to delete the false publication from its online data base, and from all the platforms posted, issue a letter of apology and publish the letter of apology on all the platforms the original publication was made. In response, Felix Ashimole, Esq. stated as follows:

"I have this and many more documents, including the record of proceedings that will bury you if you want us to go on this route."


Our client is the Chaiman of Neighborhoods, Estates and Resident Association of Abuja. Inter alia, our client is the President of his Nigerian Law School, Class.
